

Confluent Statement on SVB

March 12, 2023

As disclosed on the Company's fourth quarter and fiscal year 2022 earnings call, Confluent ended the fourth quarter 2022 with \$1.93 billion in cash, cash equivalents and marketable securities. Virtually 0% of the \$1.93 billion balance is exposed to Silicon Valley Bank.
